2. SPACE IN THIS SALE IS AVAILABLE ON A FIRST COME FIRST SERVE BASIS AND ANY NOMINATION MUST BE RECEIVED BY FRIDAY MARCH. 16, 2012. NOMINATED ANIMALS MUST HAVE A LEGIBLE TATTOO THAT MATCHES THE REGISTRATION.
3. ALL ANIMALS SHOULD BE SOUND BREEDING ANIMALS. THE ASSOCIATION RESERVES THE RIGHT TO REJECT ANY UNSOUND ANIMAL FROM THE SALE. ALL CATTLE NEED TO BE CLEAN AND IN GOOD CONDITION. UPON ARRIVAL THERE WILL BE A THREE PERSON COMMITTEE TO INSPECT CATTLE BEFORE UNLOADING. ANIMALS NEED NOT BE HALTER BROKE AND SHAVED (Head clipped would be nice). A GOOD PRESENTATION IS BEST.
4. A \$30.00 NOMINATION FEE & REGISTRATION PAPERS ARE DUE WITH THIS FORM FOR EACH ANIMAL. ALL DNA TESTING SHOULD BE COMPLETE BY SALE DAY. THERE WILL BE NO BUY BACK FEE IF NOMINATION FEE HAS BEEN PAID.
5. ALL CONSIGNORS ARE TO BE A MEMBER OF THE ABBB. ALL MEMBERSHIPS AND ACCOUNTS ARE TO BE PAID IN FULL BEFORE PAPERS WILL BE FORWARDED OR TRANSFERRED.
6. CONSIGNORS ARE RESPONSIBLE TO GET THEIR CATTLE TO THE SALE.
7. ALL CATTLE MUST BE ACCOMPANIED BY PROPER HEALTH PAPERS IN ORDER TO TRAVEL TO THE STATE OF ARKANSAS.
8. ALL BULLS 16 MONTHS AND OLDER MUST BE SEMEN TESTED. SEMEN TEST MUST BE ON FILE AS THE ANIMAL IS CHECKED IN. ALL BULLS MUST MEET REQUIREMENTS OF THE STATE OF ARKANSAS FOR TRICHOMONIASIS. (REGULATIONS ARE ATTACHED TO THE SALE GUIDELINES).
9. ALL FEMALES SHOULD BE POTENTIAL BREEDING STOCK. FEMALES NEED A VET TEST TO STATE WHETHER THE ANIMAL IS OPEN, READY TO BRED, PUT IN AN ET PROGRAM OR BRED.
